(i)	The particulars of its organization, functions & duties	<p>St. Aloysius College, Elthuruth, Thrissur, Kerala is an institution of Higher learning affiliated to the University of Calicut. It is run by Fathers who belong to the Congregation of Carmelites of Mary Immaculate (C.M.I.). St. Aloysius College is founded as per the provisions of the Indian Constitution, Part III Article 30(1) and administered by St. Marys Monastery, a House under the Devamatha Province of the CMI Congregation . The college is aided by the Govt. of Kerala and affiliated to the university of Calicut. It is listed under the sections 2(f) and 12 (B) of the UGC act and has been reaccruited by NAAC with B grade (CGPA 2.84) in 2013. The college offers graduate and post-graduate courses in Arts, Commerce and Science as well as various UGC aided B Voc and Career Oriented Programmes and short term courses.</p>
(ii)	The powers & duties of its officers and employees	<p>The Principal is the executive head of the institution and he looks after the administrative, academic and financial affairs of the college. The policy decisions are taken by the Governing Body while the College Council and the Internal Quality Assurance Cell (IQAC) monitor the regular work and progress of the institution including teaching-learning and research. Heads of the Departments work under the Principal and manage the academic and administrative affairs of the departments. The teaching staff carries out the regular teaching and research and also discharge responsibilities as the parts of various committees and help to run the institution.</p>

The Finance Officer and the Bursar monitors the financial matters of the institution.</p> <p>The institution is monitored through regular meetings of the Governing Body, the College Council and the IQAC where policy matters are discussed and decisions are taken.
