- Sub:- College Union Election 2019-20 Notification and schedule to conduct the election Forwarding of Reg.
- Ref:- (1) Order of the Vice Chancellor in the file of even number dated 12.07.2019 and 22.07.2019.
 - (2) The judgement of the Hon'ble High Court of Kerala in the WP (C) 25875/2017.

I am to inform you that the Vice-Chancellor has ordered, vide read (1) above, to notify the College Union Election 2019-20 on 08.08.2019 and to conduct the polling on 29.08.2019. Detailed schedule is attached herewith (Appendix III).

The election shall be conducted in all the colleges / institutions affiliated to the University of Calicut, in any one of the three modes suggested by the Lyndgoh Committee report approved by the Hon'ble Supreme Court of India and in compliance with the revised College Union Election rules of this University, which are in force now. You may, therefore, take urgent steps to conduct College Union Election 2019-20 in your college as per the above provisions and also as per the other requirements of the University's College Union Election rules.

As per the reference cited (2) above, the Hon'ble High Court of Kerala has ordered that the colleges are bound to follow the time schedule prescribed in the notification, since on the basis of representatives elected from the colleges, the University Union Election is to take place.

The Returning Officers may make changes in the scheduled dates and time, if necessary, except the date of notification and date of polling. The name and designation of the person appointed as Returning Officer shall be intimated to this office along with the results.

The Returning Officer need to keep a copy of (i) the preliminary electoral roll, (ii) the final electoral roll, (iii) the list of accepted nominations, (iv) the final list of nominations, (v) the ballot papers, (vi) the statement of the returning officer with regard to the number of votes secured by each candidate for each post including the invalid etc., for future purpose to redress the complaints in this regard, if any, and to produce the same before the enquiry committees or courts of justice, if required.

The Syndicate has decided not to permit the part-time students to participate in the election

process. Hence, only those students, who are enrolled in full time courses are to be included in the electoral roll. The Syndicate of the University clarified the Rule V(4)(vii) of the Calicut University College Union Election Rules as "the candidate shall have one opportunity to contest for the post of Office Bearers (i.e. Chairman, Vice Chairman, Secretary and Joint Secretary) and two opportunities to contest for the post of an executive member (i.e University Union Councillor, Fine Arts Secretary, General Captain, Student Editor, Class Representatives and Association Secretaries). This matter may also be informed along with the election notification for the convenience of the fresh students. The University Grants Commission (UGC) has directed to include NOTA (None Of The Above) option in the voting system for Election of Students Union. Hence, you are requested to include the column NOTA - 'None Of The Above' option also in the ballot paper / Voting Machine.

All the colleges affiliated to the University of Calicut shall conduct the College Union Election as per the schedule attached and the election results and other documents as stated below, signed by the Returning Officer and countersigned by the Principal shall be forwarded to the undersigned within 15 days after conduct of the election, so as to enable the university authorities to conduct the University Union Election properly.

The documents to be submitted to the undresigned after conducting the College Union Election are as follows:

- 1. Appendix-I, which includes the specimen signature and Photograph (Passport size) of each University Union Councillor.
- 2. An affidavit of the Returning Officer in Appendix-II,
- 3. An additional copy of the photograph of the UUC with name of the UUC written on the reverse side of the photograph and attested by the Principal (This photograph and the photograph affixed in Appendix I should be identical),
- 4. List of all elected candidates with name of posts, and;
- 5. Copy of the appointment order of the Returning Officer

The names of the UUC(s) from your college will not be considered for inclusion in the Electoral Roll for the University Union Election with out the above documents. The Appendix I and II attached with this letter shall be used for sending the details.
